Although I like modern display, a more traditional vernacular style might appeal to older prospective clients (so long as it incorporates energy saving technology).
- 24. Approval of new CABI design. Will blend in well with surrounding environment. Village area to be traditional build with traditional materials.
- 25. Great idea good luck. Just worried about the by-pass and speeding cars.
- 26. A very stimulating proposal which will meet a growing need to provide suitable residential facilities for an ageing population. I fully support it.
- 27. Your development plans seem to take account of all the environment issues and are well thought out. I hope you are successful and that your new premises enable you to continue your work.
- 28. Can you make sure that the site lighting has minimal impact ie light pollution.
- 29. The Care Home is an excellent idea. I'm concerned that the present lay-out of the home is not very practical, old people need to feel in touch with 'CABI activities' and at present the Extra and Bed Care are too 'out on a limb'. They cannot walk very far so facilities need to be close to their housing. I have experience regarding Richmond Village at Letcombe Regis where a friend (age 88) is in the Assisted Living Apartments.
- 30. Sharing of electric cars. Why not make Wallingford an ECO town. What's happening about talking to Drs and Social Services?
- 31. A great developing the site without impacting on local infrastructure. Please don't move the bus stop towards the roundabout, it's already dangerous for Mongewell residents, this would make it worse.

- 32. Have you considered a website on the whole development and why you are doing it? Do you pull in the Howbery Farm development too? The facilities available in the new buildings could benefit the local communities – the biggest building around for 'functions' is the Regal and old cinema. How good it would be if the Eco-friendly could be followed through to the Retirement Village. Retirement Village to have Residential/Nursing – back and forth depending on health of individuals. Slopes and covered ways for wheelchairs etc. Doesn't have to be traditional 'houses' and 'flats'. Should be a show piece – electric cars, buses etc. solar panels built into roofs. Recycling of water treatment. Wildlife friendly.
- 33. Is there sufficient tree planting and area width to shield the footpath from the development so that the footpath retains its country feel. Consider daytime and dusk early morning lights shining through the footpath and also noise.
 - I like the look of the new headquarters building.
 - Could some more community use be incorporated onto the site. While talking to CABI staff a swimming pool and allotments were possibilities discussed but other things are I'm sure possible.
 - The Care Home is a good idea. Having experienced the need for care for a number of relatives, a modern care facility would be welcome. Its only at an outline stage but a few suggestions:
 - For domestic care areas ensure there are outdoor/garden areas that can be accessed at all times. These need to be very safe.
 - All older residential care patients need access to the fresh air so consider balconies and other options for them too.
 - The field to the side of CABI is scruffy and unattractive, can it become more attractive (but not developed) as part of the development?
 - Bus stop a pull in space for the bus would be good.
 - Style of building for the care village: no views. Anything well-built and as carbon neutral as possible.

Staff comments

- 1. The Bus Stops. I'm pretty certain we (CABI) don't want the bus stops to be on the main road, yet that's where they are currently suggested to be? I think this is a really bad idea. It's a very busy dangerous road for pedestrians, particularly at peak traffic times in the morning and evening. The A4130 runs East/West as it goes past the site so in the winter, peak traffic coincides with a low Sun leading to visibility and judgement of traffic issues. I do not think that many vehicles will be expecting any pedestrians to be on either side of the road. Crossing the road, even with a pedestrian safe zone will be tricky I think. Given that this is an assisted living development as well, I'd venture to suggest that a good many users will be of more limited mobility. It would be far safer to have the bus pull into the site and pick up/set down passengers there. There can be shelter and a site based point offers far more in terms of general safety for those using the service. As a person who enters and leaves the site, I can also say that having buses slow and stop on the main road also leads to issues with entry and exit to the current site. It's worse when it's dark and the weather is inclement.
- CHP and ground source heat I think there was some mention of this? I would think the site would be an excellent place to have heating provided by ground source heat pumps.

- 3. A personal plea I'm an amateur astronomer. Light pollution is something that I think should be minimised wherever possible. I'd love for the site to be class leading in terms of full cut off lighting, and perhaps using LED light sources etc to ensure evening/night illumination whilst not contributing to light pollution in the area. There are too many culprits around this part of the world! <u>http://www.britastro.org/dark-skies/guidelines.html</u> has some info in this area (it's not the greatest site in the world).
- 4. The plan for the bus stops seemed rather odd, when there could be elderly people using them moving them up the hill seems the wrong way to go. Also siting the safe crossing refuge even further away will probably mean it is not used because people won't want to walk away and back. My suggestion would be to consider doing something that fits with the existing public foot path and underpass in the other direction. The underpass would be much safer for those not too quick on their feet.
