# CABI BACKGROUND

CABI (www.cabi.org) is a not-for-profit development-led organization supported by a solid scientific research base and a world class publishing service. Our mission is to improve people's lives worldwide by providing information and applying scientific expertise to solve problems in agriculture and the environment. Our work increases food security and protects biodiversity.

We have over 400 staff based in 16 countries. We have offices in Brazil, China, India, Kenya, Malaysia, Pakistan, Switzerland, Trinidad & Tobago, the UK and the USA.

CABI is an intergovernmental organization that can trace its origins back to 1910. Our mission and direction are influenced by government representatives from our 46 member countries who help guide the activities we undertake. These include scientific publishing, development projects and research, and microbial services. We are also leading a major new initiative, Plantwise, which aims to improve food security and the lives of the rural poor by reducing crop losses.

#### **Publishing**

We produce key scientific publications, including CAB Abstracts – the world-leading database covering agriculture and environment and Global Health - the definitive bibliographic database for public health information. We also publish multimedia compendia, books, ebooks and full text electronic resources aiming to further science and its application to real life. Behind each of our products is a team of subject specialists committed to delivering the most relevant and authoritative information to researchers worldwide.

## **Development projects and research**

Our staff research and find solutions to agricultural and environmental problems. We use science, information and communication tools to help solve issues of global concern. Our work is arranged around four core themes:

- Commodities we work to enable smallholder commodity farmers to compete in global markets. We diagnose and control plant pests and diseases, and help farmers get a better price for their crops. We work on crops such as coffee, cocoa, wheat, rice and cotton.
- Invasive species we are helping to reduce the spread and impact of invasive weeds such as Japanese Knotweed, water hyacinth and insects such as coffee berry borer and cocoa pod borer. We also advise countries at a policy level about agriculture, trade and the environment.
- Knowledge for development we work with farmers, extension workers, researchers and governments to deliver agricultural knowledge and develop communication strategies and systems.
- **Knowledge management** we use information and communication technologies to provide farmers, researchers and policy makers with the information they need to make informed decisions and to lift people out of poverty.

#### Microbial services

We manage one of the world's largest genetic resource collections, the UK's National Collection of Fungus Cultures. We conduct microbiological identifications, provide cultures for sale, and offer preservation and consultancy services. We are also screening our collection, looking for natural products such as antibiotics, vitamins and enzymes.

#### **Plantwise**

Plantwise aims to increase food security by providing knowledge. It helps poor farmers in developing countries improve their livelihoods by losing less of what they grow to plant health problems. This will be achieved through expansion of the plant clinic network which CABI has already begun to establish, supported by the creation of a global knowledge bank of information on plant health, pests and diseases. ## Purpose of the role

The Business Solutions Architect is a new CABI-wide role that sits in the team responsible for driving forward CABI's product innovation agenda. This role requires a talented technical solutions architect to produce application designs that meet the business requirements of projects and programmes, and also align with the wider CABI IT architectural strategy. The holder will be responsible for the end-to-end solution process. This involves working with colleagues across CABI to undertake requirements gathering and specification design, to guide IT development teams through the delivery of the solution, to carry out user acceptance testing (internal/external) and to achieve project sign-off. The role has a CABI-wide scope and is at the cutting edge of making innovative data-driven knowledge products and workflow solutions, across both desktop and mobile platforms. This role includes working on both backend business rules and platforms as well as on the front-end user experience.

The Business Solutions Architect will report to the Head of Business Solutions within the Publishing business unit, but will liaise with all parts of CABI on a global basis, ensuring that both business and technical solutions specified and delivered are fit for purpose and consistent with CABI vision, IT Strategy and the strategic road maps for key products and services. They will be part of a Solutions Team agile cycle working with both IT and business colleagues.

## **Candidate profile**

You will either come from an IT technical / digital background and be seeking to work closer with the business, or from a business background and be interested in the latest technical innovations and how to deploy them in a business context. You will have a strong technical and business rules understanding, ensuring that CABI exploits the latest / best tools for the management, enrichment, integration and delivery of knowledge to the different user communities which CABI serves.

You will have at least 3 years demonstrable experience in driving forward product and/or platform innovation, having shown a passion for continuous improvement and the deployment of new technologies to achieve improved business outcomes. You will be able to identify appropriate tools and techniques for CABI's needs and gather / map user requirements. You like keeping track of the latest developments by attending meetings, seminars and monitoring activities online.

- To define product scope, requirements and contribute to implementation plans
- To ensure that solutions have the best possible user experience to match & exceed the expectations & requirements for both internal & external user needs
- To build in depth understanding of relevant areas of CABI systems architecture and capabilities
- To manage, when appropriate, the internal and external stakeholders and vendor relationships
- To work with colleagues across CABI to develop a number of technology workshops and guides to empower employees on using data to inform decision making
- To champion the use of analytics to support the management and future development of the full range of CABI products
- To attend and contribute to user groups and similar information exchange networks
- To assist the Head of Business Solutions in achieving the unit's goals
