Issues related to food security, malnutrition, climate change, food loss and poverty are common to many countries including Malaysia and is better to be addressed in a collective manner. So, I call upon all of you today to play and active part in this consultation session to further strengthen

the role of CABI in bridging scientific knowledge and building strategic partnerships among its member countries especially in the Asia-Pacific Region.

4. On a local note, this consultation is very timely as well. We are approaching our 11th Malaysian plan which will begin in 2016. Aiming for productivity-driven economic growth, the 5 year plan encourages up-skilling (teaching new skills) and re-skilling (retraining staff) as well as research through increased industry-academia collaboration, more targeted skills training programmes and increased support for industrial and social innovation activities. In the field of agriculture as well, emphasis will be on increasing productivity through the modernisation of the sector, supported by greater innovation and research and development. All of these initiatives are in-line with CABI's roles and functions, so I am sure for Malaysia, we will be able to complement CABI in its missions and future endeavours.

With the recent signing of a new Memorandum of Understanding on Agriculture, MARDI-CABI relationship should further prosper in the future as it entails and aims to forge more win-win and synergistic collaboration in the future.

6. One example of such cooperation is the "Workshop on the diagnostics of whiteflies" which was held recently in September 2015. The training workshop was jointly organized by MARDI, CABI and ASEANET and ASEAN-Australia-New Zealand Free Trade Agreement (AANZFTA) which is managed by the Department of Agriculture Australia. The focus of the workshop was to learn efficient techniques for collection, preparation and identification of the major groups of pest whiteflies including the biology, taxonomy and the quarantine risk associated with different species. This workshop was represented and benefited all ASEAN countries and is a good regional initiative.

7. I am sure MARDI-CABI relationship can further grow to benefit not only Malaysia, but other member countries of CABI. With a good volume of research scientists, personnel, expertise and leading-edge infrastructure in MARDI, there is much room for future cooperation. Perhaps CABI and MARDI can have a joint laboratory that can be utilized together to benefit ourselves and other member countries in the region. MARDI and CABI should also embark on future international programs perhaps under the ASEAN or APEC umbrella.
