CABI is a not-for-profit international organization that improves people's lives by providing information and applying scientific expertise to solve problems in agriculture and the environment.

Our mission and direction is influenced by its member countries who help guide the activities undertaken. These include scientific publishing, development projects and research and microbial services.

CABI helps address the issues of global concern, such as food security through science, information and communication. We do this by improving crop yields and combating threats to agriculture from pests and diseases, protecting biodiversity and safeguarding the environment, and improving access to agricultural and environmental scientific knowledge.

## **CABI** – a membership organization

CABI was established by a United Nations treaty-level agreement between 48 member countries. Each member country has an equal role in the organization's governance, policies and strategic direction, in addition to enjoying a number of privileges and services relating to our scientific expertise, products and resources.

Most importantly, membership of CABI gives national governments a leadership role in directing and influencing the global development agenda through the work of the organization and its international network of partners.

This short brochure outlines the benefits of being a CABI Member Country in more detail and explains the roles and responsibilities of the representatives responsible for membership in their country.



## governance – shape CABI's future

CABI is run by you, for you. As a member you have the opportunity to direct and benefit from our work to solve agricultural and environmental problems. Your contributions help people in less developed parts of the world to improve their lives. You have the opportunity to shape CABI's future either through the formal Governance mechanism or other consultation processes.

### **Review Conference**

The overall governance of CABI comes from the Review Conference of Member Countries, which reviews CABI's work programmes and determines its broad policies and strategies. Review Conferences are held every two years.

### **Executive Council**

The Executive Council approves CABI's annual accounts and budgets, the admission of new members and key policy decisions. Executive Council usually meets once a year with additional postal or e-mail communications as necessary to monitor CABI's affairs and implement Review Conference resolutions.

### **Regional Consultations**

We regularly hold consultations to understand the key issues affecting agriculture and the environment in our Member Countries. Together, we develop priority areas which CABI has a capability to address in some way. Through the consultations CABI aims to align its work with national and regional needs, develop frameworks for activities and set a path to ensure these are appropriately funded, resourced and translated into vital and effective programmes.

Current priority areas

- Trade development and good agricultural practices for market access
- Institutional capacity strengthening and knowledge management
- Monitoring and adaptation to climate change
- Integrated pest management in relations to high value crops
- Technology transfer and exchange between countries
- Protecting biodiversity and ecosystem services

## projects, products and services

CABI implements development and research projects and publishes high quality scientific resources. Members benefit from free, priority or discounted access to a range of these projects, products and services.


Our **Plantwise** programme is helping countries establish community-based plant clinics which deliver practical advice to farmers when their crops have a problem. We aim to have clinics in 40 countries by 2016 and are prioritising member countries in the roll out plan.

Every member country can use up to three day's consultancy per year to support the development of joint policy papers, concept notes or project proposals. Unused days can be banked for up to five years. We offer special rates for longer research or consultancy projects.

We offer a range of professional microbial services and members can use CABI's in-house expertise for free or discounted identifications of microbial samples\*.

### Benefits at a glance

- Free access to CABI information products for one institution or governmental agency (member countries in Bands 1 – 4)
- Free microbial identification service for Member Countries (Bands 1-4). The maximum number of microbial samples that may be submitted per qualifying institution is ten per year (with a maximum of five samples submitted at any one time)
- Discounts on purchase of CABI information products
- Free policy and project development support (up to 3 consultancy days) and special rates for longer research or consultancy projects
- Use of CABI facilities worldwide at preferential rates
- Priority considerations for CABI training courses
- Access to the CABI Development Fund for joint project development
- Input to CABI research activities and delivery of research, development and communication programmes meeting national and regional priorities. Including priority considerations in CABI's global initiatives (eg. Plantwise)

Liaison Officers work together with Executive Council members as the focal point for information between CABI and your Government departments and institutions, and to encourage prompt payment of CABI membership fees.

The **Executive Council member** plays a key role in CABI through the regular Executive Council meetings held in London.

Here CABI's accounts are signed off and the budget approved. As the membership contact in the UK we hope you are able to encourage any action required by your Liaison Officer on important information, including papers that require policy decisions.

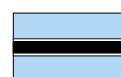
