## CABI's mission to improve lives

CABI is an international not-for-profit organization that improves people's lives by providing information and applying scientific expertise to solve problems in agriculture and the environment.

By sharing knowledge and science, we tackle global issues like poverty, hunger, education, equality, sustainability, climate change and biodiversity. Operating under a UN-registered international treaty-level agreement, CABI's core areas of work are guided and influenced by its 48 Member Countries, representing almost two thirds of the world's population.

CABI is committed to supporting its Member Countries and their farmers, especially smallholders, by addressing global issues such as food and nutrition security, and in doing so, contributing to the broader agendas aligned with the UN Sustainable Development Goals (SDGs), particularly those relating to trade, plant health, gender equity and climate change.

With over 100 years' experience working in agriculture and the environment, and a physical presence in more than 20 locations around the world, CABI works with its Member Countries and vast network of partners to make a difference in the world, utilising CABI's scientific and knowledge management expertise, publishing products, tools, biological resources and services.

# Working together to tackle global challenges

Membership of CABI enables national governments to play an active role in directing and influencing the global development agenda through our work and our network of partners.

CABI Member Countries set our strategic direction which means that our work in development, research and scientific publishing helps Member Countries to tackle their problems in agriculture and the environment while addressing global issues of concern such as food security and climate change.

Membership of CABI can be viewed as an international extension of a Member Country's national capabilities in agriculture and the environment. We can also help link Member Countries, donors and partners, to facilitate triangular and multilateral collaboration and regional and international development initiatives.

Through its programmes and projects, CABI works in partnership with Member Countries, donors and partners to help farmers grow more and lose less, combat threats to agriculture and the environment and improve access to scientific information. For example:

- CABI's prestigious **Plantwise** programme supported over 54 million smallholder farmers worldwide to help reduce crop losses, increase food security and improve livelihoods.
- CABI and partners used a novel combination of earth observation technology, real-time field observations, and plant-pest lifecycle modelling to deliver a science-based **Pest Risk Information Service (PRISE)** for countries in sub-Saharan Africa.
- The CABI-led **Fall Armyworm Research Collaboration Portal**, launched to help facilitate greater collaboration on fall armyworm research, is the official platform for the Fall Armyworm Research for Development International Consortium.
- CABI has trained more than 22,000 farmers and 35,000 workers as part of the **Better Cotton Initiative** to help Pakistan's cotton industry reduce losses of around \$350m/year incurred through poor production, transport and storage practices.

## Membership types and benefits

There are two types of country-level membership: Full Member Country and Associate Member Country. A Full Member Country enjoys voting rights at formal governance sessions and meetings, while Associate membership enables a country to join CABI faster. An Associate Member Country has Observer status at Executive Council meetings and the formal governance sessions within Review Conferences.

Each Full Member Country has an equal role in the organization's governance, policies and strategic direction, and with both memberships, Member Countries gain from a number of privileges and services relating to our scientific expertise, projects, products and resources.







## Projects, products and services

**Through its projects, CABI works in partnership with Member Countries, donors and partners to help farmers grow more and lose less, combat threats to agriculture and the environment and improve access to scientific information.**

With more than 100 years of applied scientific research underpinning our work, CABI supports study, practice and professional development through an extensive array of publishing products, research services and support tools which includes online databases and compendia, knowledge tools and portals, digital learning packages, books and eBooks.

Member Countries benefit from free, priority or discounted access to a range of these projects, products and services.

## Highlights in the benefits package include:

- **Strategic advisory support** on operational matters for Plantwise-active countries (the majority of which are CABI Member Countries) through national coordination mechanisms, to sustain existing in-country partnerships and share new PlantwisePlus developments. PlantwisePlus, an evolution of Plantwise and CABI's Action on Invasives programmes, will comprehensively support farmers and countries in a changing climate to further predict, prepare for and prevent plant health threats, helping to improve the quality and quantity of food grown.
- Up to **five day's consultancy per year** to support the development of joint policy papers, concept notes or project proposals and scoping studies.
- **Access to CABI's flagship knowledge products** including the world-renowned CAB Abstracts and Global Health databases. The most comprehensive bibliographic database of its kind, CAB Abstracts helps governments and institutions around the world access up-to-date academic and technical knowledge and innovative, cutting-edge research to enable better evidence-based decision and policy making by providing over 10 million bibliographic records, full-text articles, news items and reports across the applied life sciences in one convenient platform. With over four million records in public health, Global Health helps thousands of professionals in government institutions around the world access a wealth of knowledge in public health, helping them to understand the current situation and make critical decisions – an essential tool in a world facing the COVID-19 pandemic.
- **Access to the CABI Academy** which builds on CABI's scientific and publishing background, translating the latest innovations in crop and plant health research into programmes designed to help students and professionals focusing on crop pest diagnosis and management solve problems in agriculture and the environment.
- **Free or discounted use of CABI's professional applied microbial identification services.** CABI's in-house expertise includes full microbial investigation, identification, detection and testing services for all types of fungal and bacterial contamination problems that might be causing disease to agricultural crops. These services are supported by CABI's collection of over 30,000 living strains from 142 countries, one of the world's largest genetic resource collections.
- An opportunity for researchers and journalists in Member Countries to obtain tailored advice on access to, and use of high-quality online training programmes, resources and consultancy on effective **science communication provided by SciDev.Net**. SciDev.Net, owned by CABI, is an independent source of news, views and analysis about science and technology for global development.

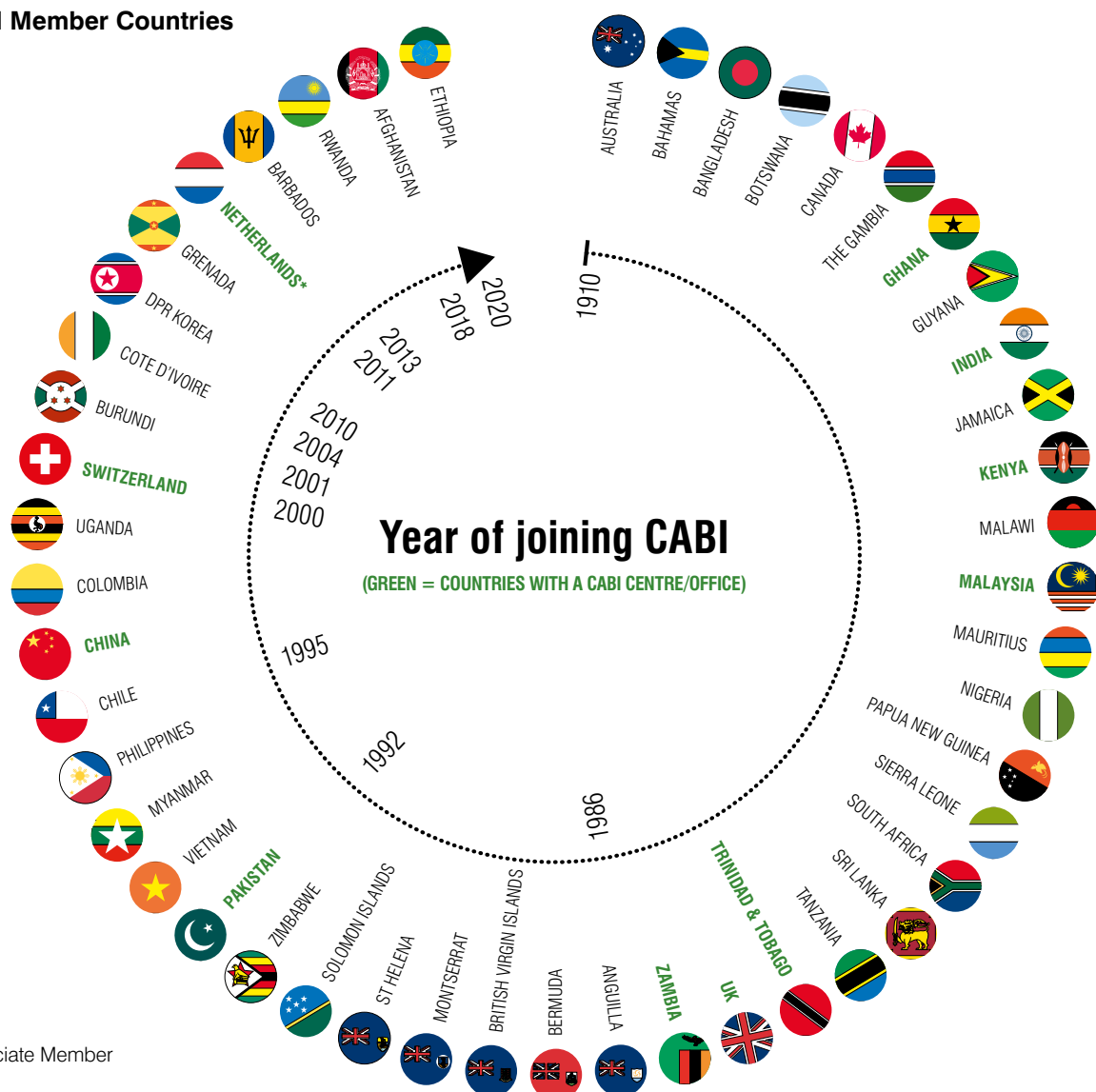
CABI works hard to identify new opportunities for collaboration, especially south-south collaboration and those related to technology transfer.

# CABI MEMBERSHIP BENEFITS – OVERVIEW

**Member Countries shape CABI's future through formal Governance mechanisms and other consultation processes. These include:**

## Review Conference

Central in the overall governance of CABI is the Review Conference of Member Countries, which reviews CABI's work programmes and determines our broad policies and strategies. Review Conferences are held every three years.

## Executive Council

The Executive Council approves CABI's annual accounts and budgets, the admission of new members and key policy decisions. The Executive Council usually meets once a year with additional postal or e-mail communications as necessary to monitor CABI's affairs and implement Review Conference resolutions.

## Regional Consultations

CABI regularly holds consultations to understand the key issues affecting agriculture and the environment in its Member Countries, agree priority areas for working together, and address them in its medium-term strategies. Through the consultations, CABI aims to align its work with national and regional needs, develop frameworks for activities and set a path to ensure these are appropriately funded, resourced and translated into vital and effective programmes.

CABI's current strategy and work focuses on:

- Food and nutrition security
- Climate change and biodiversity
- Gender and youth
- Economic development
